



PRIVACY POLICY

This Privacy Policy lays down the collection, usage, protection and sharing of your Personal Information or Sensitive Personal Data, in accordance with provisions of the Information Technology (Reasonable Security practices and procedures and sensitive personal data or information) Rules, 2011.

Personal Information:

Personal information refers to such information that can directly or indirectly identify a person like the full name or email address, etc.

The type of Personal Information collected from you may include your full name, address, telephone number and email address which shall be used by us for providing the services to you.

Sensitive Personal Data:

Sensitive Personal data refers to the information of a person that is more sensitive in nature which includes passwords, financial information namely bank account, biometric information, etc.

Collection of information:

The information pertaining to your identity and demographics shall be collected by us for enabling us to provide better services to you.

Usage of your information:

Any of the information we collect from you may be used in one of the following ways:

- (ix) To carry out research and analysis to study customer use and experience on an anonymous or personalized basis

Your information, whether public or private, will not be sold, exchanged, transferred, or given to any other company for any reason whatsoever, without your consent, other than for the express purpose of delivering the purchased product or service requested. We may, however, share personal information to our group companies, for providing better services to you, if you expressly consent to do so.

Protection of information:

We implement a variety of security measures to protect your personal information from unauthorized access or disclosure. Further our employees who have limited access to your personal information are bound by Non-Disclosure and Confidentiality Policies.

Disclosure of information:

We do not sell, trade, or otherwise transfer to outside parties your personally identifiable information. This does not include trusted third parties who assist us in operating our website, conducting our business, or servicing you, so long as those parties comply with applicable laws and agree to keep this information confidential.

We may have to disclose your personal information or sensitive data with Government agencies or other law enforcement agencies, if we are called upon to do so, for the purpose of



investigation or otherwise. Further, non-personally identifiable visitor information may be provided to other parties for marketing, advertising, or other uses.
